#### MINUTES

##### CALL TO ORDER/INVOCATION:

Chief Dobbs called the meeting to order, and Paul Attocknie gave the Invocation.

##### DECLARATION OF QUORUM:

Secretary Isabella Clifford declared a quorum with six (6) members present.
