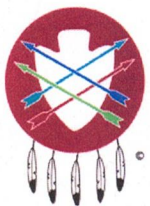

PEORIA TRIBE OF INDIANS OF OKLAHOMA BUSINESS COMMITTEE MEETING July 22, 2026

MINUTES

CALL TO ORDER/INVOCATION:

Chief Dobbs called the meeting to order. First Councilman Nick Hargrove gave the Invocation.

DECLARATION OF QUORUM

Secretary Isabella Clifford declared a quorum with five (5) members present. Second Councilwoman Kara North was absent.

APPROVAL OF AGENDA:

Nick Hargrove made a motion to approve the agenda with the correction to add the guest speakers from Health and Services and was seconded by Jason Dollarhide. Motion passed.

APPROVAL OF MINUTES:

Isabella Clifford made a motion to approve the minutes of the Regular Meeting held on July 22nd 2026, with corrections to include "Motion Passed" under New Business: Discussion/Approval of Agreement for Access to Motor Vehicle Registration Records with the Oklahoma Turnpike Authority and seconded by Nick Hargrove. Motion passed.

GUEST SPEAKERS: Wendy Rich with Health and Human Services (HHS), Jonathan Jacobs with Peoria Care and Sabrina Steven with Sunshine Mental Health presented on services that could be billed by the Tribe if a LLC was created for mental health/substance abuse services. This new LLC would be financially beneficial to the tribe and fill a needed area of services in the community.

Discussion of Special General Council Meeting (7-11-26): Nick Hargrove discussed his belief that an operational audit would assist in transparency for the citizens with concerns regarding the tribe's businesses. Resolution R-07-22-26-A, “Resolution Enacting The Inter-Tribal Title 23 Wildlife Code Conservation Regulations, Chapter 4 Of The Inter-Tribal Wildlife Code, And Inter-Tribal Wildlife Code Definitions”: Motion was made by Paul Attocknie Jr. and seconded by Scott Myers to approve Resolution R-07-22-26-A. Motion passed.

Resolution R-07-22-26-B, “Resolution Authorizing Tribal Historic Preservation Officer To Physically Repatriate The Peoria Tribe Archaeological Collection To Miami Oklahoma Permanently”: Motion was made by Paul Attocknie Jr. and seconded by Nick Hargrove to approve Resolution R-07-22-26-B. Motion Failed.

Resolution R-07-22-26-C, “Resolution Authorizing Submittal Of The Tribal Heritage Grant Program Funded By The Historic Preservation Fund Administered By The National Park Service”: Motion was made by Paul Attocknie Jr. and seconded by Nick Hargrove to approve Resolution R-07-22-26-C. Three For and Two Opposes. Motion passed.

Resolution R-07-22-26-D, “Resolution Authorizing Purchase Of Vehicle Through The Tribal Maternal, Infant, And Early Childhood Home Visitation Grant”: Motion was made by Paul Attocknie Jr. and seconded by Nick Hargrove to approve Resolution R-07-22-26-D. Four For and One Oppose. Motion passed.

PUBLIC COMMENTS:

Citizen Jonny Skye: Comments concerning feasible study for the Recovery Services from HHS, changes to the quarterly flier, services focused on citizens rather than the community, cultural building layout, and elders project.

Sarah Harris, Director of Finance, shared her information about operational audits with the comment about the length of time you can go back with useful information, pros to get a snap shot of the past and limitations to the audit with a suggested plan moving forward as she mentioned at last month’s BC meeting.
