MINUTES

CALL TO ORDER/INVOCATION:

Chief Dobbs called the meeting to order and Second Chief PJ Attocknie Jr. gave the Invocation.

DECLARATION OF QUORUM

Secretary Isabella Clifford declared a quorum with six (6) members present.

APPROVAL OF AGENDA:

Nick Hargrove made a motion to approve the agenda and was seconded by Scott Myers. Motion passed.

APPROVAL OF MINUTES:

Paul Attocknie Jr. made a motion to approve the minutes of the Regular Meeting held on June 17th, 2026, and seconded by Kara North. Motion passed.

UNFINISHED BUSINESS:

New Business

Discussion of Constitutional Town Halls & Update : Nick Hargrove informed the Committee that the local BIA Agency was given secretarial delegation to handle Peoria constitutional election without the revisions needing to go directly to the Secretary of the Interior and he informed them of the process to start.

He suggested mailing out a survey to Tribal Citizens to find locations for the Town Halls.

Discussion/Approval of Public Boundary Signage: Nick Hargrove informed the committee on Oklahoma policy regarding tribal boundary signs. Nick made a motion to put up Tribal boundary signs within our Reservation area and was seconded by PJ Attocknie. Motion Failed, with two for and four opposed.

Discussion/Approval of Election Ordinance Revisions: Paul Attocknie made a motion to approve the Election Ordinance and Scott Myers seconded. Kristin Gillman discussed the process of the Peoria Election and the changes that the Election Committee has made to the Ordinance for BC approval. Motion failed to approve the Peoria Election Ordinance. Motion was made by Kara North and seconded by Scott Myers to table the Peoria Election Ordinance. Motion failed.

Resolution R-06-17-26-A, "Resolution Authorization And Signatures With Arvest Bank For New Account Entitled Buffalo Run Casino RV Park". Nick Hargrove made a motion to approve R-06-17-26-A and seconded by Kara North. Motion passed.

Resolution R-06-17-26-B, "Resolution Naming The Chief As The Authorized Signatory On All Contracts Or Legal Documents Pertaining To The Peoria Tribe Of Indians Of Oklahoma". Nick Hargrove made a motion to approve R-06-17-26-B and seconded by Paul Attocknie. Motion passed with five for and one Opposed.

Resolution R-06-17-26-C, "Resolution Authorizing Submittal Of Application To The Rural Communities Opioid Response Program Planning Grant". Motion was made by Nick Hargrove and seconded by Kara North to approve Resolution R-06-17-26-C. Motion passed.

Resolution R-06-17-26 D, "Change Of Date For July 15th, 2026 Regular Business Committee Meeting". Motion was made by Nick Hargrove and seconded by Scott Myers to approve R-06-17-26-D, moving the meeting to July 22nd. Motion passed.
