

Peoria Pow Wow Vendor Space

Basic Terms and Conditions

Contract

This application, properly executed by applicant (vendor), shall upon written acceptance constitute a valid and binding contract.

Assignment of Space

Assignment of booths by the Peoria Tribal Pow Wow Committee is final and shall constitute an acceptance of the vendor's offer to occupy space. After assignment, space location may not be changed, transferred, or canceled except with the approval of Peoria Tribal Pow Wow Committee. Subletting or licensing of space by the vendor or use of the space not authorized by Peoria Tribal Pow Wow Committee is prohibited. Booth assignments will be made on a first come basis. Specific requests will be considered by the Committee. *Traders will be permitted to enter the Pow Wow Grounds for set up after Noon on Friday, June 25th, 2021.*

Types of Exhibits

Exhibits shall be limited to arts and crafts of American Indian motif and/or design that are consistent with the theme of the event. Interpretation of the meaning and intent of this restriction shall be the sole prerogative of the Peoria Tribal Pow Wow Committee.

Booth Space Rental rates

Booth space rental rates will be \$50 for arts and crafts for all three days. Fees are payable in cash or money order for each booth space measuring 10' x 10'. Requests for multiple booth spaces will be accommodated. Vendors are to provide their own tables, chairs, extension cords, and other equipment needed to display goods. **Vendors will be required to provide an item, valued at not less than \$25, as a fundraiser donation for the Peoria Tribal Pow Wow Committee.**

Payment Requirements

Payment in the form of **cash or money order** is required with vendor's application. Make all money orders payable to **Peoria Tribal Pow Wow Committee** and mail to: Peoria Tribal Pow Wow Committee, Peoria Tribe of Oklahoma, PO Box 1527, Miami, OK 74355-1527.

Security and Insurance

All property of the vendor is understood to remain under his custody and control, in transit to, within, or from the confines of the pow wow grounds, or exhibit building, subject to the rules and regulations of the event. Vendors are advised to carry floater insurance to cover merchandise/material against damage and loss and the public liability insurance against injury to the person and property of others. It is recommended that vendors take precautionary measures of their own such as the securing of small or easily portable articles of value.

Loss or Damage

Vendor agrees with Peoria Tribal Pow Wow Committee that Peoria Tribal Pow Wow Committee will not be liable for any damage or liability of any kind or for any damage or injury to person or property during the term of this agreement, from any cause whatsoever by reason of use, occupation, and enjoyment of exhibit space by vendor or any person thereon with the consent of vendor, and that vendor will defend, indemnify, and save harmless Peoria Tribal Pow Wow Committee from any liability whatsoever, and account of any such damage, or injury, whether or not caused by negligence of or breach of an obligation by exhibitor or its employees or representatives.

Demonstrations

No demonstrations or solicitations shall be permitted outside of the vendor's assigned space, and no signs or placards may be displayed on persons or otherwise outside vendor spaces.

Compliance

The vendor assumes all responsibility for compliance with all pertinent ordinances, regulations and codes of duly authorized local, state, and federal governing bodies concerning fire, safety, and health, together with the rules and regulations of the event and the Committee.

Management

The vendor further agrees that the conditions, rules, and regulations of the Peoria Tribal Pow Wow Committee are made a part of this contract and that said vendor agrees to be bound by each and all of these rules and regulations, and that the Committee shall have the full power to interpret, amend, and enforce all rules and regulations in the best interest of the Peoria Tribe Pow Wow Committee.
